A message from the Principal

Dear St John's Families,

Earlier this week we celebrated All Saints Day and All Souls Day. Each year we recall the example, witness, and prayer of the holy women and men who have been identified by the Church as Saints. These saints are often looked upon by us as role models; often being examples of ordinary people who were called to do the work of God. Every year when we celebrate All Saints Day, the Gospel we proclaim recalls for us Jesus' teaching about happiness, the Beatitudes. The Beatitudes can be understood as a framework for Christian living and outline God's gift of blessing granted to those who choose to live as His disciples. Saints are people who lived the spirit of the Beatitudes as Jesus lived. On this day, we too are challenged to model our lives on the spirit and promises of the Beatitudes.

For me personally this is a big week as my son turns 18 and will finish his last HSC exam on Friday. Swimming Programme

A message from the Assistant Principal



ONLINE SAFETY

The eSafety Commissioner (eSafety) is Australia's independent regulator for online safety.

The <u>esafety webpage resource</u> is available for free online and outlines some advice for parents of school age children.

Using technology has become a part of our daily lives and we should work together to ensure students use the internet in a safe and responsible manner.

The webpage explores Online Safety Basics and outlines 3 Key Strategies for parents.

1. Be engaged, open and supportive

- Get involved. Share online time with your children as part of family life. Play games together. Talk about favourite apps, games or websites.
- Keep lines of communication open. Ask about their online experiences, who they are talking to and whether they are having any issues.
- Reassure your child they can always come to you, no matter what. Let them know you will not cut off internet access if they report feeling uncomfortable or unsafe when online this is a real concern that may stop your child from communicating with you openly.
- If you notice a change in behaviour or mood, talk to your child about it. If you are concerned, consider seeking professional help from your GP, a psychologist or school counsellor.

2. Set some rules

- Set age-appropriate rules for devices and online access, with consequences for breaking them.
- Get your child's input this will help them understand risks. As they get older you can review your rules together.
- Consider creating a family tech agreement (sometimes called a family media plan or family online safety agreement). This is a set of rules about how devices, like smartphones, tablets, computers, TVs and gaming consoles are used in your home. It is written down and agreed to by all family members and kept in a place where everyone can see it, such as on the fridge.
- Your family tech agreement could cover the type of websites that can be visited, time spent online and acceptable online behaviour.
- eSafety has created downloadable family tech agreement templates for families with children under 5 or those
 with kids aged 5 to 8 years. For families with older children, The Family Online Safety Contract from
 ThinkUKnow Australia is a good starting point.
- The consequences for breaking the rules should be clear. Negotiate these with your child when you create your agreement so they mean something to them Raising Children Network has some useful tips and advice.
- Consider making some 'rules for parents' too and stick to them! Model behaviour that you would like to see.

Use technology and get information

- Get to know the devices you and your children use and set them up for privacy and online safety. Take advantage of parental controls to monitor and control screen time and access to content, based on your child's age and experience. See our guide to parental controls.
- Choose apps and games carefully and visit the App Store or Google Play for age ratings and consumer advice. Read the Australian Classification Board's online database for information about movies and games.

Your support and guidance can give your children the confidence to make sound decisions online – and ask for help when they need it.

Extended Leave

As you know it is very important that children attend school every day. Quite often leave is requested by parents for various reasons. While we understand that this may be necessary sometimes, it is not encouraged as every school day is important for every child.

If you intend taking your child out of school for **five days or more you must make a formal application in writing to the principal and fill out an 'Application for Extended Leave' which is available from the school office.** It is important for you to know that, depending on circumstances, this leave may not be granted. Each application will be considered on an individual basis and could depend on circumstances such as the intention for the leave, your child's attendance, and the impact the leave may have on your child's academic progress.

These regulations are in place to make sure that your child achieves to his/her full potential and we know you will understand the reasoning behind them.

Work Health and Safety Reminders

Covid - Changes to self-isolation requirements

On 30 September, National Cabinet announced that from Friday 14 October 2022 people who test positive for COVID-19 do not need to self-isolate. In line with this announcement, the NSW Department of Education has worked with NSW Health to support all schools to adapt to this change while continuing to prioritise student and staff wellbeing by minimising the risk of COVID-19 transmissions.

t is recommended that staff and students continue to stay home if they are sick. We will continue to call parents to collect their child if they are displaying cold or flu like symptoms.

Anyone who believes they have been exposed to COVID-19 is recommended to monitor for symptoms, test, and wear a mask if they are concerned. If you test positive on a rapid antigen test (RAT) please<u>register</u> this with Service NSW (note that such registration is now voluntary). Voluntarily registering your result can help you access medical support from NSW Health, including antiviral medicines if you are eligible. It also assists NSW Health to respond to the ongoing COVID-19 pandemic.

Continued COVID-smart measures

At St John's we will continue to operate with the 'baseline' COVID-smart measures in place throughout Term 4 to minimise transmission and to prioritise student and staff wellbeing. This includes a combination of layered safety measures – we continue to encourage mask-wearing along with the use of rapid antigen testing (RAT), good ventilation in indoor settings as well as extra cleaning of high touch surfaces..

Visitors attending the school continue to be encouraged to wear a mask, particularly when indoors and/or when physical distancing is not possible.
